- 1) I hereby acknowledge receiving the above described cat(s)/dog(s).
- 2) I understand that the cat(s)/dog(s) shall remain the sole property of S.T.A.R. and S.T.A.R. reserves the right to reclaim the cat(s)/dog(s).
- 3) I agree to return said cat(s)/dog(s) if I am no longer able to care adequately for them.
- 4) I agree to provide the cat(s)/dog(s) with loving care, including but not limited to food, water, shelter and medication when required.
- 5) I understand that I do not have any authority to keep or place foster cat(s)/dog(s) in other homes or with other individuals unless approved by Robert Shapiro, Director of S.T.A.R.
- 6) I understand that said cat(s)/dog(s) will be available for adoption during the time in my foster care. I agree to allow the cat(s)/dog(s) to be viewed by potential adopters with 24 hours notice, or sooner if possible.
- 7) I understand that as the foster I have the first right of adoption of any cat(s)/dog(s) in my care when adoptive homes are available.
- 8) I understand that S.T.A.R. cannot guarantee or be held responsible for the health, behavior or temperament of any cat(s)/dog(s) that I may foster, and I am aware that foster cat(s)/dog(s) may cause personal or property damage while in my care.
- 9) I understand that my foster volunteer position can be terminated at any time if my actions or conduct are deemed detrimental to the best interests of S.T.A.R.
- 10) I agree to be available to answer any and all questions Robert Shapiro might have about the cat(s)/dog(s) in my care.
- 11) I agree that Robert Shapiro or another authorized representative of S.T.A.R. have permission at any time (within reason) to visit my home for inspection of the cat(s)/dog(s) in my care.
- 12) I agree to defend, indemnify, and hold harmless S.T.A.R, Robert Shapiro, any previous owner or foster home from any and all liability associated with the dog(s) or damage or injury hereafter caused by the cat(s)/dog(s).
